- Experience in working with all levels of users driving and developing data definitions for process and systems changes, strong ability to extract and analyse large and complex data sets and technical expertise regarding data models, database design development, data mining and segmentation techniques.
- Experience with databases, data lakes and data warehouse design, development, and implementations.
- Experience with conducting analytics, data transformation, and visualization using tools such as SQL Server, T-SQL, Python, Java, JavaScript, MatLab, Microsoft R, Visual

Studio, Azure Databricks, Azure Data Factory, Azure Synapse, Microsoft PowerBI, and IBM Cognos.

### **Duties:**

- Conduct in-depth analysis and mining of complex PIC business data (including operational and performance) to identify opportunities for business improvement and answer specific business questions through the identification of patterns and correlations among the various data points.
- Data integration services including mapping and tracing data from system to system to solve a given business or system problem.
- Turn massive and complex amounts of structured and unstructured data sets into useful information to solve PIC challenges.
- Ensure the stability and reliability of data access and data quality across the organisation.
- Documenting technical specifications for data solutions that specify pertinent information such as data sources-to-target maps, types, structure (logical and physical models), flows, data dictionary transformations, storage, and reports.
- Conduct data solution design, evaluate viable solutions, build/develop and implement in line with PIC data governance practices.
- Promote integrity, reusability, maintainability, reliability and scalability in the design and development of data solutions.
- Liaise with internal and external stakeholders to gather business requirements and translate these into specifications whilst enriching business understanding of their data.
- Analyse and resolve problems in existing data / extracts / reports / queries, and then implement corrective actions.
- Participate in data management and auditing, querying advanced data analysis and identification of anomalies as per defined policy.
- Provide and apply quality assurance best practices for data analysis services across the organization.
- Lead the acquisition and management of data feeds services (e.g., JSE, Bloomberg, Iress, Refinitiv, MSCI, etc.) and subscription services across the organisation.



- Drive data architectural designs for assigned projects and provide enterprise-wide technical data assistance and cross-training.
- Participates in project planning, daily stand-up meetings (scrums), reviews, retrospectives, sprint and release planning, and other Scrum-related meetings.
- Provide data analysis services during the lifecycle of projects/products to ensure successful implementations.
- Define all data requirements for projects and ensure the adequacy of tests during the project.
- Identify and manage data risks in line with PIC Enterprise Risk and Data Management frameworks.
- Create awareness within the IT team and put in place a process of addressing and managing data issues.
- Ensure that all applicable regulatory requirements are adhered to.
